THE DEAL HOUND 2H19: WHAT TO KNOW

- ☐ Industry consolidation in the veterinary hospital group space shows enduring strength
- ☐ Growth is driven by fundamental societal and generational change
- ☐ Active players are moving quickly

Long Fragmented, Veterinary Services Experiencing Consolidation

In the pet product and services industry, an identifiable shift in how people see and treat their pets drove an emerging wave of veterinary hospital acquisitions and regional rollups in 2H 2019 as the industry consolidates. A wave of young adults in their 20s are having children later in life – if at all – opting instead for pets, which become true members of a family. This "humanization of pets" is fueling demand for veterinary hospitals that provide a holistic approach, offering everything from routine checkups to advice on, and access to, affiliated high-end products including organic or specialty pet foods, vitamins and wellness supplements, prescription medication, etc.

Doggone Booming: Shore Capital Partners

Chicago-based Shore Capital Partners is a case in point: after working with two emerging veterinary hospital groups to establish Detroit-based Mission Veterinary Partners in 2017, Shore has been on a tear, building Mission from 22 hospitals to more than 50 in less than two years. In the second half of 2019 alone, Mission added five veterinary hospitals across the Midwest, a unit growth rate of more than 10 percent in less than six months.

But that's not all Shore has been up to in the space. Since it began working with another regional group, Southern Veterinary Partners, in 2014, Shore has continued to grow the Birmingham, Alabama based veterinary hospital chain, adding eight practices in the second half of 2019. Southern currently boasts 112 veterinary practices, serving more than 1 million pet patients a year. In 2019, Inc. magazine named Southern one of the country's fastest growing privately held companies, earning the highest growth ranking of any veterinary company.

Off and Running

Private equity investors have latched onto an opportunity for growth that shows no signs of slowing. Forbes magazine calls the space "highly fragmented" and "recession proof," fed by consumers with disposable income who pay directly for services at the point of sale. Forbes predicts the trend will continue for years, even as rumors that major players including pet food producers Blue Buffalo and Nestle – are starting to sniff around. As private equity continues bundling and building, the end product may be too enticing for an ultimate buyer to resist.

Looking upstream at the macro trend of pet humanization, it's apparent young adults, slower to have children, are driving the trend. And while Millennials are aging and may begin to settle down, Generation Z - the next rising generation, born after 1997 - is even larger than its predecessor at some 90 million. As members of Gen Z continue embracing pets and seeking ways to care for them, the demand for veterinary services must keep up. While harnessing the psychology of this change in consumer spending in the space, look for increased demand that goes beyond emergency veterinary care and into:

How much of a societal shift has pet humanization become? The social media influencer marketing agency Everywhere reports there is now an established trend of "pet influencers" on Instagram, and a national auto seller has tapped into pet lovers by experimenting with a "park and bark" pet-centric sales event. The agency argues that for young adults, pets are now considered "starter kids."

M&A Trends to Watch

In 2020, the convenience of one-stop care and product recommendations, paired with a growing trend in pet humanization, bodes well for an M&A space already running hot. In the coming year, look for:

- ☐ Continuing rollups in the veterinary hospital space
- ☐ Geographic expansion and diversification across regions
- ☐ The looming impact of a mega-sized generation of consumers poised to graduate from college and start new, independent lives

There's no indication the current trend of veterinary hospital rollups will abate. The oldest of booming Gen Z has just turned 22. As they stream out of college, set off on their own, yet continue to delay starting families later than prior generations, the market for pets and pet-related services and products stands to benefit. Pets remain a safer, less demanding alternative to children for a financially gun-shy generation that grew up in the Great Recession. Pets are not only less expensive than children, but they offer companionship with less intense needs while providing an opportunity for young, cautious couples to test how the dynamic of an added responsibility in the home will challenge a budding relationship.








