- ☐ Consumer tastes and expectations are driving changes in how food is delivered around the world.
- ☐ Everyone from farmers to restaurants are exploring new methods for food delivery.
- ☐ Tech investors are pouring big money into the sector in search of answers.

Distribution & Logistics: Farm Fresh, Fast

Perhaps as much as any sector, the food distribution industry is experiencing a seismic shift as the entrenched distribution path from farm to retail is challenged by technology, consumer tastes, and today's needit-now sentiment. While still delivering perishable items, distributors are being pushed to find ways to expand beyond rail car delivery and largescale wholesale distribution to reach all the way to the ultimate destination: the consumer.

The Supply Chain Sprouts New Links

Traditionally, food distribution ran down a one-way stream. From the farms and ranches of agribusiness, food flowed to processors and manufacturers who converted raw materials into consumer packaged goods (CPG). From there, transport companies delivered individual goods to a food distribution warehouse where they were carved into smaller shipments destined for retail outlets including supermarkets, convenience stores, and restaurants for sale to the consumer. But consumer behavior is changing. Customers want more - more variety, more specialty foods, and more delivery options. Everything from the rapid growth of farmer's markets to technology is challenging the food distribution model. Consumers have come to expect they can make an online grocery order at Whole Foods and have it delivered in two hours or order a box of perfectly measured raw ingredients for a week's worth of homemade meals. Even restaurants that typically didn't deliver now do, thanks to meal-delivery platforms such as GrubHub and DoorDash. Annual digital meal delivery is expected to grow to \$467 billion over the next five years, a 31% increase.

Add to this the popularity of farm-to-table restaurants requiring more frequent deliveries while consumers focus on "fresh" ingredients without processing or preservatives. These new demands diminish the time between fresh and spoiled, putting new pressure on distributors to deliver from the beginning of the chain to the end consumer faster and more efficiently. The food distribution chain is experiencing disruption from a combination of ecommerce, technology, and consumer expectations.

Order Up, It's a Global Thing

Merger and acquisition activity in food distribution covered the gamut throughout 2019, from traditional trucking to lastmile bike couriers, from regional startups to global capital.

- ☐ As 2H19 closed, Performance Food Group Company completed the acquisition of Reinhart Foodservice, establishing PFG among the largest distributors in the U.S. with about \$30 billion in annual net revenue and nearly 25,000 employees. The company said the acquisition extended its geographic reach, diversified its customer base – including the addition of independent restaurants – and is expected to deliver substantial cost savings built on scale.
- ☐ Japanese conglomerate Softbank made a \$1 billion bet on Colombia-based delivery service Rappi that allows customers to use a mobile app to order quick delivery of food or medications from restaurants, grocery stores, and pharmacies. The company's bike couriers and their bright orange backpacks are ubiquitous across Colombia's capital, Bogota, while services are now offered in multiple South American countries. Softbank has also gone in big with investments in the U.S. food delivery service industry with DoorDash and Uber, which includes its meal delivery service Uber Eats.
- ☐ Uber, in turn, made an international play in 2019, acquiring Latin American grocery delivery service Cornershop.

- □ And while delivery services came into vogue, Floodgate an early investor in both Lyft and Taskrabbit and Fuel Capital, led a \$3 million round of funding in 2H19 for a Seattle-based startup called Dumpling, which aims to better manage the personal grocery shopping market.
- Overseas, French company Carrefour acquired Dejbox, a company that specializes in delivering workplace meals to employees at companies located outside of urban centers. Carrefour announced plans to grow by allowing employers to subsidize workers' lunch breaks by transferring funds into their Dejbox account.

Opportunity in Disruption

For the business owner and the capital investor, opportunities continue to lie in embracing the change and staying ahead of developments. As much as any company, Amazon recognizes disruption and reacts. The company has launched its Delivery Service Partner program, offering to help entrepreneurs launch their own parcel distribution businesses with discounted vehicle leases, uniforms, training, tax software, and more. Is philanthropical Amazon helping put America to work, or is it undercutting established distribution networks while getting into the vehicle lease and uniform sales industry – all while shedding the cost of maintaining its own employees and insurance?

As the food distribution industry develops, investors are finding opportunity in technical innovations, packaging, last-mile delivery, and more precise methods of delivering an ever-increasing array of specialty foods. Looking ahead, it's hard to see anything short of continued disruption. Meal kits may be a fad, but what's next? Everything from meatless meat to the "democratization of taste" create demand for more products in smaller batches. Add to that a focus on renewable energy and cleaner vehicles and pressure from traditional retailers facing their own challenges from a fragmenting consumer base and a market-share loss of higher-margin products such as cleaning supplies to home delivery services, and it no surprise that The food distribution sector can expect more disruption, with potential opportunities for the engaged, proactive, and agile.




TRANSACTIONS BY SEGMENT


