### 1H 2019 M&A OVERVIEW

The first half of 2019 saw a continuation of robust M&A activity in the Health & Wellness Industry, as strategic acquirers have rapidly pursued inorganic growth strategies to position themselves more competitively in today's saturated market. SDR tracked 67 transactions involving businesses participating in and serving the Health & Wellness sector. Most notably, the Natural & Organic Foods, Health & Fitness, and Vitamins, Minerals, & Supplements segments led the pack with 15 recorded transactions each including several noteworthy deals closed so far this year. The Personal Care segment also continues to experience significant acquirer interest, with 12 deals recorded in 2019, including the largest transaction in the industry year to date - JAB Cosmetics' acquisition of an additional 20% stake in Coty for \$1.7 billion in cash.

Strategic buyers and sponsor-backed platforms continue to dominate the M&A landscape in the Health & Wellness sector, accounting for three quarters of all activity so far this year. Although new sponsors are now increasingly seeking platform acquisitions from which to grow, as demonstrated by Swander Pace Capital's investment in Bragg Live Food Products and TSG Consumer Partners' acquisition of CorePower Yoga, industry participants continue to outpace pure funds in their pursuit of attractive targets.

The average EBITDA multiple for publicly traded Health & Wellness companies by the end of the first half of 2019 held steady since the end of 2018 at 12.5x LTM EBITDA. The Activewear segment traded at the highest average multiple of all segments at 15.2x EBITDA and the Vitamins, Minerals, & Supplements segment traded at the lowest multiple of 9.2x.

# NATURAL & ORGANIC FOODS

The Natural & Organic Foods segment has been among the most active in the Health & Wellness Industry in the first half of 2019. With 15 recorded transactions so far this year, it is clear that this segment's incredible compounded annual growth rate of over 11% since 2005 has bolstered M&A activity in the space. Some notable transactions involving Natural & Organic Food Products this year have been:

- Nagase Holdings America Corp. agreed to acquire a 93.6% majority stake in Prinova Group for \$621 million. Prinova is an international supplier of ingredients, flavors and value-added nutrient fortification products. The acquisition will expand the food business of Nagase Holdings and create synergies for both companies.
- Taylor Farms acquired Earthbound Farm, a subsidiary of Danone U.S. engaged in the production of organic salads, fruit and vegetables for \$500 million. This deal will expand Taylor Farms' capabilities into the fresh produce category.
- Litehouse agreed to acquire Sky Valley Foods for \$46 million. The transaction will expand Litehouse's organic products and its manufacturing presence on the East Coast.

### **HEALTH & FITNESS**

M&A activity in the Health & Fitness segment has significantly accelerated through the first half of 2019; SDR tracked 15 transactions in the sector year to date, compared to 13 total in 2018. It is notable that the Health & Fitness segment is the only active subsector in the Health & Wellness Industry that had more acquirer activity coming from pure financial sponsors versus strategic acquirers or sponsor-backed platforms. PE funds have been forced to compete with other industry participants to establish thriving platforms in the increasingly competitive space. Some of the more notable transactions involving Health & Fitness companies this year have been:

- KPS Capital Partners signed a definitive agreement to acquire the assets related to the fitness business operations of Brunswick Corp for \$490 million in cash. The business being acquired manufactures and sells commercial fitness equipment and billiards game tables and furnishings.
- TSG Consumer Partners LLC acquired CorePower Yoga, a portfolio company of Catterton Management Co and Amzak Capital Management, that engages in the operation of yoga fitness studios, for an undisclosed amount.
- A private group led by Morgan Stanley Capital Partners acquired Impact Fitness from Bain Capital Double Impact and Bridges Fund Management for an undisclosed amount. Impact Fitness operates gym and fitness centers throughout the U.S.

# VITAMINS, MINERALS, & SUPPLEMENTS (VMS)

Unlike the Health & Fitness sectors, M&A activity in the Vitamins, Minerals, & Supplements segment has entirely been driven by strategic acquirers in the first half of 2019. Large and recognizable CPG brands have continued to pursue VMS targets as a way to differentiate their product offerings and strategic positioning in the marketplace. Noteworthy deals in 2019 have included:

- PepsiCo acquired CytoSport from Hormel Foods Corp for \$465 million in cash. CytoSport, Inc. manufactures nutritional supplement products and the acquisition will include the Muscle Milk and Evolve Brands.
- Neptune Wellness Solutions signed a definitive agreement to acquire Sugarleaf Labs for \$150 million. Sugarleaf Labs extracts cannabidiol oil and offers tinctures, topicals and liquid soft gel capsule products.
- Glanbia acquired Watson for \$89 million in cash, and following the transaction, Watson will be part of GN Nutritional Solutions. Watson manufactures and supplies nutritional products for the food and beverage industry.

## PERSONAL CARE

The Personal Care segment experienced less transaction volume than the three previously highlighted sectors, with 12 deals tracked by SDR in the first 6 months of 2019. That being said, this subsector has seen no shortage of notable strategic acquirers angling to add Personal Care offerings to their product portfolios, including Unilever, Procter & Gamble and JAB Cosmetics. Below are a few significant transactions that occurred in this segment year to date:

- JAB Cosmetics acquired an additional 20% stake in Coty for \$1.7 billion in cash, representing a 21% premium to the closing stock price of Coty on February 11, 2019. Coty manufactures and distributes branded beauty products.
- Unilever agreed to acquire Tatcha, a portfolio company of Castanea Partners, Finn Capital Partners, and Beechwood Capital, for \$500 million in cash. Tatcha operates as a luxury beauty and lifestyle company.
- LG Household & Health Care agreed to acquire New Avon, a manufacturer and distributor of cosmetics and beauty products, for \$125 million in cash. The acquisition will strengthen LG Household & Health Care's international growth plans.
- Procter & Gamble agreed to acquire This Is L, a manufacturer and distributor natural personal care products, for a reported value of \$100 million. The acquisition complements Procter & Gamble's existing portfolio of feminine care products.






