MANUFACTURING 1H20: WHAT TO KNOW

- ☐ This has been one of the most unusual, unanticipated periods in memory with a global viral pandemic catching consumers and manufacturers by surprise. Nothing is normal.
- ☐ The spike in unemployment this spring appears to be easing, opening a path for the return of consumer demand.
- ☐ We believe those who have maintained a solid capital position and remained open to opportunities stand to benefit when M&A activity resumes to typical levels.

Manufacturing in 2020: Didn't See That Coming

If there has ever been an ode to uncertainty for the manufacturing sector, it's 1H 2020. The first half of the year started with the threats we knew tariffs, trade, fickle consumer habits, and the cyclical nature of the economy - and then dove head-first into the unknown realm of the global COVID-19

And if there's a sector that responds quickly, for better or worse, to external factors, it's manufacturing. For the record, 2020 has been the year

Early into the pandemic, we witnessed an explosion of consumer demand for manufactured goods as people stocked up for stay-at-home orders, the heyday of the toilet paper industry. Then an unemployment rate that was well below 4% prior to the pandemic rocketed to nearly 15% by April. Even with a rebound as the half ended in June, unemployment hovered around 11%.

All of this has made for an "interesting" first half of the year. Interesting being a word no investor likes to hear. It has been difficult to get a full picture, but there have been indications manufacturing is finding its footing. After a challenging spring, the Purchasing Manager's Index (PMI) in June rebounded from 41.3% in May to 52.6% in June, an encouraging sign that broke historic records for production and new order growth indicators, according to the Institute for Supply Management (ISM). Timothy Fiore, chair of the ISM's Manufacturing Business Survey Committee, called April the "bottom of the taboggan run." We will see, because those numbers were set prior to a renewed spike in coronavirus cases later in the month. Another reminder of the uncertain times we live in.

What next? That's the question that faces M&A activity in the second half of the year. Companies may be unsure about capital expenditures if there isn't an uptick in demand. That demand may change dramatically as well, working at home may mean less demand for cars and car repairs for commuters, but increased demand for home office supplies, electronics for students studying online, and home repairs for those stuck in the house for too long.



After taking a punch in the gut beginning in March, the manufacturing sector's June rebound is encouraging. Then as the second half of the year opened, the U.S. saw more coronavirus cases and new debates about reopening restaurants, theme parks, and schools. More uncertainty.



Ripples Up and Down Manufacturing Channels

As people and governments struggle to grasp the impact of this virus, we've been watching a broad disruption of the supply and demand chain end to end. When families finished stocking up, there was a collective "what next" moment. With people locked in their homes and restaurants, schools, and businesses closed, consumer demand and behavior shifted to an increase in e-commerce and a "homebody economy" that moved from going out to staying in. While demands shifted, supply – as in the ability of manufacturers to produce – also dried up as workplaces closed for health concerns.

Particularly hard hit was the meat packing industry where hog and cattle processing decreased by nearly 40%, roughly 20% of Wendy's fast food restaurants ran out of fresh beef, and international demand for U.S. exports tumbled. (Read more about the impact on food production in our Food & Beverage Reports).

Then, from consumer product manufacturing, the ripple spread again. When consumer wants shift, people are out of work and trim discretionary spending, production is challenged, and future demands are unknown, CFOs turn their eye to capital expenditures. Shelving capital expenditure plans is one of the quickest and most impactful ways to preserve cash. Companies across sectors and around the world trimmed capital expenditure plans from 10% to 80%.

Dramatic cuts like that affect the manufacturers who make the heavy equipment and big-ticket items. While declines in consumer demand affect manufacturers, the heavy equipment manufacturers are facing headwinds at both ends, declining capital expenditures and global supply chain disruptions. Manufacturers are left fighting challenges from Main Street USA to Tiananmen Square.



A Tale of Two Quarters

The first quarter of 2020 saw largely business as usual. Tariffs and trade issues lingered, but with little disruption to consumer demand and low unemployment, mergers and acquisitions were not uncommon.

Internationally, we saw the private equity firms Advent International and Cinven, together with the RAG-Stiftung, announce in February an agreement to acquire Thyssenkrupp AG's elevator technology business. Thyssenkrupp, a German company that produces passenger and freight elevators and moving sidewalks with customers in more than 100 companies including the U.S., declared revenues of about \$90 billion in the 2018-2019 fiscal year.

At the end of January, Volkswagen subsidiary Traton, one of the world's largest commercial vehicle makers, moved to acquire Navistar International Corporation at a 45% premium over Navistar's stock price prior to the offer. Traton already owned nearly 17% of the company. Then Traton reported a big drop in sales and profit as the pandemic took hold and admitted the sector's future was uncertain.

"It is currently impossible to predict when a new forecast for the current fiscal year will be possible," the company reported. "The effect of the corona pandemic on customer demand, supply chains, and production cannot be assessed reliably at this point in time." There it is again: uncertainty.

Surprises Abound

As we monitor the sector's pulse, we're seeing companies react in unprecedented ways as they navigate the new reality. Spice giant McCormick pivoted marketing from in-store demonstrations to online support and encouragement for families stuck at home and adjusting to home-cooked meals. Mattel introduced a new line of action figures featuring our new "front line heroes," delivery drivers and grocery clerks. And General Motors subsidiary Cruise deployed its selfdriving cars in San Francisco to help food banks deliver essentials across the city.

In the near term, the pandemic sparked unusual consumer demands. Leading the pack as the virus sunk its teeth into the economy were household supplies such as toilet paper (what was that about?) and cleaning supplies, followed by essentials such as diapers, packaged foods, pet supplies and alcohol. Meanwhile, the out-of-home "necessities" fell out of favor, with cuts in cosmetics, motor oil, office supplies, and cell phones.

And when people are stuck at home, they apparently want to improve their environment. During the pandemic, 70% of surveyed homeowners said they intended to launch a home improvement project. Companies such as Lowe's, Home Depot, Scotts Miracle-Grow, and Sherwin-Williams spiked as a trips to the movies and dinners out were replaced by a new refrigerator and coat of paint.



Now What?

Looking ahead, we're where we started this pandemic, coping with uncertainty. What next? More rounds of federal stimulus? A second wave of infections? (Or did the first wave ever end?) A vaccine? Until we emerge with a solution, manufacturers may continue to experience the effects of both supply chain disruptions and battered consumer good sectors where store closings or bankruptcies struck major players such as Nordstrom's, J.C. Penney, and Neiman Marcus, and travel services such as Hertz rental cars and international airlines LATAM and Avianca.

And we've still got those trade and tariff issues to think about. The White House has declared any phase 2 trade deal with China as an afterthought. And then there are November's elections.

But when things sort themselves out, we feel those who have maintained strong capital positions stand to reap the rewards of a potential wave of consolidation through mergers and acquisitions as weaker players find their resources depleted. For those in the best capital positions, money is currently cheap.

Meanwhile, cooped up consumers can reasonably be expected to demonstrate pent-up demand for new manufactured goods. As workplaces reopen and commutes resume, we may see a surge in automotive product demands. If businesses have found working from home worked, we could see new demands for home office supplies and workspace products. And if schools and colleges forge ahead with online learning, we may see unprecedented demands for electronics such as computers, tablets, and wireless routers. At the corporate level, capital expenditures can only be shelved for so long, and when the situation stabilizes, we anticipate those deferred plans will be dusted off and brought forward again.

Those who have remained nimble, alert, and informed throughout may be poised to take advantage of some of the strangest six months most of us have ever experienced.




TRANSACTIONS BY SEGMENT




LOWER MIDDLE MARKET PRIVATE EQUITY TRANSACTION MULTIPLES
