Q&A WITH AN INDUSTRY EXPERT

In this edition of SDR's Technology report, we interviewed the Co-Founder and Managing Partner of NuView Analytics (and former investment banker), Anthony Wong. At NuView, Anthony and his team leverage the latest technology tools to help middle-market companies create actionable insights from their data. SDR has partnered with NuView to enhance the marketing of its clients to investors in cases where the client has significant untapped data that can demonstrate key attributes, such as market penetration, performance during business cycles, reoccurring revenue patterns, etc.

Q: How are you most often seeing smart middle-market companies leverage their data to increase Enterprise Value in the eyes of potential investors/acquirers?

A: Where we see companies find the most success in creating tangible enterprise value is by leveraging their data to create efficiencies in their operations that result in increased EBITDA (i.e. decreasing costs or increasing productivity). Of course, smart middle-market companies have access to timely insights beyond their monthly financial results that allow them to identify the inefficiencies in their businesses.

We usually see the marketing and sales departments rise to the top of the list due to the large amounts of data those departments collect. Whether it's identifying marketing channels that contribute to low conversion rates or cultivating actionable leads that are most likely to close for sales, many data-driven insights can create real leverage points for sales and marketing. For technology and software companies where retention is a key driver of enterprise value, we find the most impactful data solutions are customer churn models that utilize historical data from customers' tenure to predict future churn for cohorts.

Q: For middle-market companies to win with data-driven insights, do they need to be at the forefront of utilizing AI or machine learning?

A: Al and machine learning are the buzzwords of the day in data, but the truth is they are beyond what is necessary to make an immediate impact on businesses. All companies, not just middle-market companies, can see huge wins through data-driven insights by focusing on creating a more data-informed business. Once you can see the data, and it gets insightfully presented to the end-user, middle-market companies can then make decisions and have their teams implement the insights rather than a computer. For example, it's not necessary to create an Al robot to call all your top sales leads, but it is necessary to know which sales leads are most likely to close so your team can focus its attention on them.

Q: What is the most common misconception that middle-market business owners have about the value of their data?





A: "My data is too dirty or messy to make it valuable." Every middle-market company has unexpected changes in their data or missing data that will lead to potential issues, but many companies will throw out the baby with the bathwater. Most data, even in a messy raw form, is still useful for guiding decision making in business. I think this stems from owners thinking that data needs to be the ultimate solution for their problems, thus the data needs to be perfect. More so, data needs a seat at the table to aid the team in making better decisions and driving better results (that are measured in the

Q: In terms of effectively using data to make decisions, are larger companies so far ahead of smaller competitors that it is nearly impossible for smaller companies to catch up?

A: Big companies want to talk about having AI or predictive modeling, or data-driven decision machines in place, but the truth is that they are in the same boat as smaller companies, and are actually at a disadvantage to smaller companies in that they are often in a position where they can't make a quick data-informed decision. The infrastructure in place to control and manage the business is often so complex that getting to the data is difficult, and effectuating a change based on that data depends on navigating a level of bureaucracy that is often cumbersome.

In the recent NewVantage 2019 Big Data and Al Executive Survey that surveys top analytics executives in Fortune 1000 companies, it is shown that 53% of corporations are not yet treating data as a business asset and 77% report business adoption as one of their key challenges. In short, large Fortune 1000 companies' biggest struggles are navigating data to drive business results and adoption. Middle market companies have an inherent advantage here since they can make decisions and drive adoption quickly.

Q: What is the biggest gap that middle-market companies need to address to be able to use their data to drive growth or operational efficiency?

A: Access it and begin presenting it. Many companies spend too much time searching for the right visualization tool, software or data solution, but really the right one is the one you use to make decisions, so start using something and iterate.

Additionally, part of the iteration process starts with getting some numbers in front of decision-makers and then tweaking the ones that are the biggest levers of the business. Don't get bogged down in finding the exact right metrics before you get started.

Q: For middle-market business owners who are thinking about recapitalizing their company in the next 12-24 months, what would you recommend they do to prepare for that event from a technology standpoint?

A: From a data perspective, I believe it's imperative to show that, as a business owner, you have a clear understanding of the metrics that drive your business, and that they are dialed in. From my time as an investment banker, I saw very few companies that were able to produce a dashboard that shows real-time results of key performance indicators (KPIs) in their business. I'm not talking about the monthly financial statements, but more so the actual metrics that impact the business and the ones the teams are working to continually improve.


So, from a tech standpoint, that means implementing a data visualization tool like Tableau, PowerBI, Qlik, etc. that helps you aggregate, calculate, and visualize the metrics automatically. We've been approached by more and more financial buyers (PE groups) that are attempting to implement these solutions across their portfolio. If a middle-market company can show they have already done the work, I believe PE groups would be extremely impressed. At times, a data warehouse solution would be helpful but may not be necessary for the amount of data a company has.

After a data visualization platform is in place, and if a recap was in the near future, I would focus on implementing data solutions that can immediately drive EBITDA for the recap. This can mean a lot of different technology platforms or modules, but I would mainly focus on solutions that drive down costs.





TRANSACTIONS BY SEGMENT




TRANSACTIONS BY TYPE




HORIZONTAL TECHNOLOGY SEGMENTS VS. S&P 500

OVERALL U.S. M&A ACTIVITY




