#### TECHNOLOGY 1H20: WHAT TO KNOW

- ☐ Anyone who thought there was little room for "the next big thing" in tech is getting a wakeup during the age of COVID-19. Online sales, working from home, and distance learning from grade school through college are among the drivers of a new tech boom.
- ☐ Online shopping may have been popular for the latest gadget or shoes from the dominant platforms, but stay-at-home orders are driving consumers to online ordering items not traditionally considered online strongholds such as groceries, cleaning supplies, and creating boom in online meal delivery.
- ☐ A renewed dependence for everything online is exposing gaps and opportunities - in online payment, cybersecurity, and video conferencing.

### Tech 2020: When We Can't Go Out, We Go Online

If there's a sector at the center of our new COVID-19 reality, it's technology. Social distancing and lockdowns met online payments, video conferencing, working from home, and distance learning. From end to end, technology is the new office furniture and schoolhouse. And while necessity forces innovation today, the pandemic is perhaps changing how we will conduct our daily lives even after the world returns to whatever becomes normal.

Venture capital and M&A activity may have slowed across some sectors during this economic disruption, but we continued to see deals done in the tech sector at volumes consistent with before the pandemic. And moving forward, we expect even investors who may have steered away from what could have been perceived as mature verticals to show renewed interest as we uncover new consumer demands creating perhaps some unanticipated opportunities.

### Financial Technology: Digital Dollars In A COVID World

One key sector we believe may benefit is financial technology (fintech). The pandemic has accelerated demand for fintech across virtually every platform. Online payments, financial advising, insurance, and banking will see new pressures to advance and improve. Consumers who become used to e-commerce today may never return to brick and mortar retail and merchants are turning to B2B online platforms for procurement.

Look at Stripe, Adyen, PayPal, and Shopify. International online payment facilitator Adyen experienced a 34% revenue increase from online payments in 1Q20. PayPal saw volume jump 22% in April. And Shopify saw total merchandise value up 46% as the year began.

Online shopping and a new focus on BOPUS (buy online pick up at store) sector saw not only consumers buying staples such as groceries online, but tech providers reacting. As BOPUS caught on and consumers sought to pick up pre-purchased items at stores without leaving their car, global tech

company Pivotree in April launched a turnkey BOPUS system the company says can be implemented in weeks for companies caught behind the curve. It's part of a suite the company tellingly calls Social Distancing Commerce **Enablement Solutions.** 

Perhaps testament to the potential for digital commerce opportunities, online login/checkout startup Fast announced a \$20 million infusion of cash from Stripe, a technology company that develops economic infrastructure for the internet. Impossible as it may seem, currently a minority of the world's commerce is conducted online. That leaves a lot of room for growth.

### School's Out (And Online)

The potential spread of the virus in schools had districts moving classes online around the world, exposing a big need for improvement. Already by March it was estimated some 1.37 billion students in 138 countries (3 out of every 4 children worldwide) and another 60 million teachers were working from home. Many teachers were undertrained in online education. And without broad improvements, students may not be benefiting from online classes. As schools moved online, 4 out of 10 surveyed teens said they weren't logging in. An estimated 12 million students had no broadband internet at home.

Security, digital inequality, regulation, and student participation became issues - and potential tech sector opportunities - around the world.

The thirst for enhanced online education platforms isn't expected to dry up. By the end of 1H20, colleges around the U.S. - including Harvard, MIT, and the University of California Berkeley - were announcing online-only or online/classroom hybrid models for the fall. The Chronicle of Higher Education posted a 60-page list of affected colleges on its website.





### M&A Tech: Plugging In Components

There were some big announcements – and big deals – made in 1H20 in the technology sector. The pandemic elevated tech services as companies and schools scrambled to move business online and at home.

In May, the now ubiquitous Zoom video conferencing platform made the first acquisition in its nine-year history, purchasing digital security startup Keybase as the first step in an announced 90-day sprint to repair perceived security flaws. Terms were not disclosed.

Coincidentally, communications giant Verizon announced in April it was acquiring Zoom rival Bluejeans, an encrypted, paid video communications platform. The deal was estimated at \$400 million and positions Verizon to compete with Zoom, Microsoft, and Google as companies get comfortable with work from home arrangements. In addition, the video platform is expected to pair well with Verizon's growing 5G cellular network.

In education, as schools rushed to get students up to speed with distance learning, lowa-based nonprofit ACT (known for its college admissions tests) acquired ScootPad, a developer of online curricula for elementary school students. ScootPad incorporates adaptive technology the company says detects gaps in student knowledge. The California company says it has more than 1,000 learning paths, and lessons are tailored to meet individual student needs. ScootPad reports it is used by hundreds of thousands of students. As ACT moves away from admissions tests, it has invested more than \$10 million in New Markets Venture Capital, which focuses on developing educational programs.



### COVID Locks Us Down And Opens A Door

By the end of 1H20, the pandemic was only in high gear for a few months, but its impact was already tremendous. Those who saw tech as a maturing industry dominated by the giants Microsoft, Amazon, Google, and Apple should be changing their vantage point as the world changes around us. Behaviors globally are changing, and once people get used to a new reality, it's going to be hard to bring them back to the old ways. Companies who said they couldn't support work-from-home arrangements are doing just that. Educators who dragged their feet with online learning are racing to catch up. Shoppers who shunned online grocery delivery are firing up their tablets. Meal delivery platforms, video conferencing, telehealth, virtual reality platforms, and robotics have been thrown into a new, higher gear.



### TRANSACTIONS BY SEGMENT




### TRANSACTIONS BY TYPE






