

TECHNOLOGY 1H21: WHAT TO KNOW

- ☐ There's a global race in biometric data collection and analysis, leveraging advances in artificial intelligence for analysis and touching on everything from national security to marketing and consumer product development.
- ☐ People in their everyday lives encounter biometric and behavioral collection points whether that's through surveillance cameras, voice recognition, product usage or security checkpoints. Even just driving a car.
- □ Collection and analysis of biometric and behavioral data is big business fueling continued interest in mergers and acquisitions, research, and data security.

The Boiling Frog: Biometric Data Collection And Analysis Is Already Here

If it feels like Rockwell's 1984 pop hit "(I Always Feel Like) Somebody's Watching Me" applies to your own life, you're not wrong. Facial recognition technology, data scoops, and digital recognition systems have been out there for years. A 2016 Georgetown Law report estimated 117 million Americans are logged in law enforcement facial recognition databases through largely unregulated practices. 1 A 2021 government report found 42 federal agencies – including the Transportation Security Administration, U.S. Customs and Immigration, the Secret Service, U.S. Marshals, and the FBI – use facial recognition technology in response to everything from criminal investigations to incidents of civil unrest to COVID-19 threats.²

Biometric information – your face, your eye movements, your voice, your movements ... anything that makes you, you - can be processed through a variety of A.I. applications and algorithms for any number of uses, law enforcement, public safety, self-driving cars or the development of "stickier" advertisements.

Some companies scrape facial images from social media sites and provide that data to law enforcement agencies by subscription (hundreds of them), and there are sites that gather up images from across the web and allow anyone to access them (for a fee). Anyone can track anyone, cops, an abusive ex-partner, a potential employer, identity thieves, foreign entities. Images drawn from security cameras, social media sites, corporate sites, anywhere, can be paired with machine learning and artificial intelligence algorithms.³

Biometric tracking is not without controversy. Members of Congress have proposed legislation to ban federal agencies from using biometric information, including facial recognition.⁴ The Security Industry Association announced its opposition to the proposal.⁵ The technology is raising eyebrows, and ire, from Moscow to Myanmar to Minneapolis.^{6, 7, 8}

But controversy is one thing. And business is business.

It's estimated that the broader global A.I. market – including healthcare, automotive, agriculture, retail, marketing and law – may grow from \$58 billion this year to \$309 billion by 2026, a compound annual growth rate (CAGR) of nearly 40%. The more narrowly defined area of facial recognition technologies by one estimate could reach \$14 billion by 2028 at a CAGR of nearly 16% using facial expression, emotion identification and other factors (palm vein identification, behavioral biometrics, retinal scans) to identify individuals for advanced security and surveillance in banking, financial services, insurance, healthcare and law enforcement. 9, 10, 11, 12

Developing In the Blink Of A (Scanned) Eyelash

Identity verification and tracking by biometrics continued to evolve at a rapid clip in 1H21. Japanese technology giant NEC in the first half of the year announced an agreement with Star Alliance airline members (a global network of more than 25 airlines including United) to incorporate opt-in biometric keys that will allow passengers touchless movement through airports, from airline to airline, using their face as their boarding pass and "digitizing the passenger journey." 13 The company also announced an agreement with two Japanese airports (including Tokyo) to provide facial recognition to allow enrolled passengers to pass through check-in and security without showing a passport, only their face. 14

Germany's Cognitec this year announced improvements to its matching algorithm and age estimation technology with neural network machine training to increase accuracy, even in cases where a person is wearing a mask or covering their face with their hands. The company boasts its latest tech can even generate "real-time alerts" for estimating the ages of people under 18 or 21.15

And Chinese A.I. human recognition R&D company Megvii filed for a public offering in Shanghai estimated to be worth nearly \$1 billion. Megvii is known for its Face++ recognition platform which not only includes facial detection but a "beauty score," "gaze estimation," "motion detection" and "skeleton detection" that adapts to overlapping individuals and varying positions. 16, 17

If the topics are controversial, it's not slowing research, development, innovation or implementation.

Beyond Security: Want To Play A Game?

Artificial intelligence and biometric measurements and analysis are showing up in applications beyond the scope of security and law enforcement, across any sector where machines meet (and analyze) humans. Recently acquired Lifekind has created an artificial "persona" designed to represent real people. The technology is used in digital gaming platforms to create autonomous characters. Recently, the company created A.I. technology designed to resemble the thoughts, memories and behaviors, to create interactive conversations with famous people. In June, Lifekind was acquired by Al Foundation, a developer of advanced tech it calls "Al-native Humans as a Service." 22

Analyzing human movement and behavior through A.I. is also showing up in sports. In May, London-based sports data and tech company Genius Sports acquired sports data and visualization company Second Spectrum, which works with England's Premier League, the NBA, Major League Soccer, as well as broadcaster ESPN and other sports networks. The merger was expected to provide analysis for fans, teams and sports gamblers. The deal, valued at \$200 million, was the second in a week for Genius, which also acquired FanHub and its free-to-play games and fan engagement solutions. Genius itself only just went public in 1H21 through a merger with a Special Purpose Acquisition Company (SPAC).²³

Even something as mundane as starting up the car for an errand can be tracked and dissected. Auto insurance companies offer to track driving behavior with a widget attached to the car. It's known as "black box insurance" or "usage-based insurance." Insurance companies promote tracking as a good thing, a way to save money, if you don't mind having every trip you take recorded, analyzed and stored.²⁹

Whether it's for security, efficiency, marketing or automated driving systems, tracking and analyzing human biometrics and behavior is becoming big business and is finding its way into every facet of daily life. And its only just begun.





Mergers & Acquisitions

- ☐ In June, the artificial intelligence company Smart Eye which tracks eye movement as it pursues safer transportation solutions – acquired MIT Media Lab spinoff Affectiva, a pioneer in A.I. as it pertains to human emotion and perception in transportation. Smart Eye's solutions are used by a variety of corporations as well as the U.S. military. In addition to transportation applications, Affectiva's innovations are used by global Fortune 500 companies to test consumer engagement in programming and advertising.¹⁸
- ☐ Virginia-based facial recognition company Pangiam in June announced the acquisition of California's Trueface, a facial recognition, weapon detection and age verification company. The move was Pangiam's second acquisition this year. In March, Pangiam acquired veriScan, a biometric facial recognition system for airports and airlines. Pangiam provides identity management, biometrics and advanced analytics software for both government and commercial customers focusing on operations, security, safety at airports, seaports and land border crossings. Trueface transforms video images into data for retail, hospitality, healthcare, gaming and financial services. Pangiam was created last year by the private equity firm AE Industrial Partners when the group purchased and merged PRE and Linkware. As air travel returns to normal, Pangiam reportedly wants to use its technology to create systems that allow passengers to board without a boarding pass (as the guy in front of you frantically tries to get the boarding scanner to read the QR code on his phone). 19, 20
- ☐ In the banking and financial services sector, digital recognition platforms are also watching. In June, digital identity and verification company Mitek announced the acquisition of ID R&D, a company focused on voice and facial biometric recognition designed to guard against identity theft, including the use of deep fake tech and digital voice manipulation. The deal was valued at \$49 million in stock and cash.²¹


Biometric Data Collection, Management And Analysis Is Here

The collection and analysis of biometric information is part of everyday life. Enter U.S. immigration at an airport from a foreign country, you stare into a machine that collects your photo and scans your passport. Some states collect a fingerprint for a driver's license. Enter a foreign country, and again expect to be photographed and fingerprinted. Domestic airline trusted traveler program Clear collects and uses retinal scans.^{24, 25} Once collected, can this data be lost or stolen? Apparently. In 2019 U.S. Customs and Border Protection reported thousands of photos of people and license plates collected at a land border crossing were stolen in a data breach.²⁶ This potentially expands fields not only for data collection and analysis but also data protection and security. Opportunities across the sector are opening.

The sector reaches nearly every part of our lives, from the mundane to the downright frightening. While advertisers value consumer behavior analysis, the National Security Commission on Artificial Intelligence's final report, issued in 1H21, called the international race for A.I. a "national security issue," reporting foreign governments are "transforming personal and commercial vulnerabilities into potential national security weaknesses," gathering data on Americans and using A.I. to analyze profiles of beliefs, behaviors and biological makeup to drive disinformation campaigns and cyberattacks.²⁷ The report concludes, "Americans have not yet grappled with just how profoundly the artificial intelligence revolution will impact our economy, national security and welfare."28

There's a reason we always feel like somebody's watching us.






TRANSACTIONS BY TYPE









U.S. M&A ACTIVITY SNAPSHOT




