TECHNOLOGY 2H19: WHAT TO KNOW

- ☐ When you think about the technology sector, look beyond flashy IPOs, social media, and apps. In 2020, think traffic management.
- ☐ Tech-driven Intelligent Transportation Systems (ITS) are weaving themselves into cities around the globe as traffic congestion builds and cities run out of room.
- ☐ Transportation infrastructure is a bipartisan issue. There is government will and money to fund needed upgrades, which translates to opportunity and growth in the ITS corner of the tech sector.

The Internet of Transportation: Tech Meets the Road

When thinking about technology and business opportunities in the tech sector, it's easy to imagine the next breakout from Silicon Valley or to picture Bill Hewlett and David Packard tinkering in their professor's garage. But in reality, tech today impacts everyday life – and presents opportunities for business growth and innovation – all around us in the cities where we live and commute.

Increasingly overwhelmed cities, states and countries, mired in traffic congestion, are turning to technology. The booming field of Intelligent Transportation Systems (also called Intelligent Traffic Systems), is key to improving the efficient movement of people and goods around the world.

Intelligent Transportation Systems (ITS)

The ITS sector touches everything drivers depend on as they navigate increasingly crowded roads. Think about the systems that coordinate traffic signals to combat backups and stop-and-go driving. Consider road sensors that gauge and report traffic speeds and identify congestion in real time. Traffic cameras alert emergency services to accidents while sonic sensors change traffic signals to allow rescue vehicles to speed to the scene. Look at Variable Message Signage (VMS) that warns of traffic hazards or guides motorists out of evacuation areas. ITS identifies malfunctioning traffic signals automatically, resets out-of-sync intersections, and has revolutionized toll road management. As technology evolves, traffic engineers can ping individual cell phones inside cars and use artificial intelligence to adjust signal timing for driver behaviors and react to emerging traffic patterns.

ITS *is* tech. It brings technological innovation to everyday driving, but the role technology plays in a transportation network that serves every sector of the economy may be overlooked, because when systems are working at their best, motorists don't notice them.

Demand Is Here Today, Here Tomorrow

The need for ITS is undeniable, it's a matter of physics. There are more drivers on roads that cannot be expanded. Highways are where they are,

hemmed in across urban areas by businesses, homes, hospitals, and rail lines – barriers to expansion are too big and too expensive to bulldoze. Cities are out of room.

The National Highway System alone includes 223,257 miles of roads. And that's just five percent of the aggregate road mileage in the United States. In the U.S., motorists drive some 3.2 trillion miles a year on public roads, yet traffic congestion is costing Americans \$166 billion a year in wasted time and fuel.

People worldwide are flocking to urban areas, the very places it's hardest to expand roads. In 2018, 55% of the world's population lived in urban areas, in 30 years, the United Nations expects that will rise to 68%. In North America, already 82% of the population lives in urban areas, in Latin America, 81%, in Europe, 74%.

And innovations such as ridesharing aren't helping. In 2018 The San Francisco County Transportation Authority found Uber and Lyft sparked a 50% increase in the region's congestion, creating a 47% increase in miles travelled and a 55% decrease in traffic speeds. Now factor in meal delivery services, such as Grubhub, one-day delivery by Amazon, grocery store home delivery, as well as electric scooters and bikes increasingly requiring their own lanes.

If people keep moving to cities, and more vehicles are added to the roads, and there's nowhere to build, the only solution is Intelligent Transportation Systems.

ITS: M&A Activity is Go, Go, Go

Demand for ITS isn't hypothetical. Through direct experience working with ITS-connected & enabled companies, SDR has seen an uptick in activity in this tech sector. While this M & A activity might not get the headlines of flashier tech services players such as Facebook or Salesforce make a move, there is significant activity in the field.

In 2019, Cubic Corporation - a leader in transportation technology services - acquired GRIDSMART Technologies, a video traffic tracking company for \$87 million. The move built on the prior acquisition of Trafficware in a \$235 million deal. Both were aimed at increasing Cubic's capabilities in the traffic management space, part of the company's "NextCity" strategy for solving urban congestion.

And over the past few years, another industry leader, Germany's Kapsch TrafficCom has also been active, investing some \$3 million in Traffic Technology Services, a Delaware tech company active in the connected vehicle market and provider of georeferencing and predictive information services. TrafficCom also purchased Schneider Electric S.E.'s global Transportation Business division for more than \$30 million and acquired the European digital toll collection and traffic data management firm Streetline, which serves customers in 41 countries.

Expect More

As cities, states, and countries struggle to keep up with increasing traffic volumes, look for ITS to emerge as an important component of the tech sector. Global research firm Grand View Research reports that while spending on ITS worldwide hit \$8.2 billion in 2018, that demand is expected to rise, more than doubling to \$18.2 billion over the next five years. The research firm sees growth not only in the United States, but also across the globe, with lively demand in the Asia Pacific region as rising personal wealth allows more workers to purchase vehicles and take to already crowded streets.

Moreover, there is both the money and the will in the United States to further integrate ITS technology into American cities and highways. Transportation is a bipartisan issue. Everyone benefits from less traffic congestion. The U.S. Department of Transportation has already developed an ITS strategic plan, prioritizing development of transportation infrastructure automation, and the federal government's Transportation Infrastructure Act of 2019 set aside the highest level of highway funding in history, \$287 billion over five years. The bill also acknowledges the importance of highway funding for everything from economic growth to environmental protections.


And while some industries face disruption from the promised advent of self-driving cars and trucks, ITS is poised to benefit from each innovation, further integrating collected data into smarter transportation grids.

It's hard to identify an industry that doesn't depend on transportation infrastructure, whether that's grocery, tourism, or manufacturing. As the saying goes, "If you bought it, a truck brought it." But not if that truck is stuck in gridlocked traffic





in front of a frustrated commuter and a vacationing family. The Intelligent Transportation System industry is poised to



TRANSACTIONS BY SEGMENT




TRANSACTIONS BY TYPE








OVERALL U.S. M&A ACTIVITY






